# Human Rights in Omega



We often hear people making reference to their "Human Rights" and more frequently governments and employers are becoming under pressure to ensure that the human rights of their citizens or employees are not violated. I therefore thought it important to highlight our thinking with regards to human rights. But, firstly, let us look at the concept and origins of human rights.

## Origin of Human Rights?

The modern human rights era is most likely the result of a number of struggles that happened all over the world to end for instance slavery, genocide, discrimination and even oppression by governments. For years governments unsuccessfully tried to protect individual rights and following what happened in World War II, the Universal Declaration of Human Rights (UDHR) came into being as part of the emergence of the United Nations.

The UDHR was the first international document that spelled out the "basic civil, political, economic, social and cultural right that all human beings should enjoy.

## What are Human Rights?

There are many ways to understand what human rights are and there is no one agreement on how we are supposed to identify these rights. Some prefer to see human rights as certain natural rights that were given to us by God and is therefore the state's duty to protect, while other people see them as natural rights coming from general rational human interest of gain, safety and reputation. Whichever the view, human rights, as the name suggests, are rights that all human beings have regardless of nationality, place of staying, gender, religion, language or anything else.

In Omega we regard human rights as the standards that allow all people to live with dignity, freedom, equality, justice and peace. We are all human beings and that entitles us to these rights. They are guaranteed to all of us without discriminating on the basis of race, colour, sex, language, religion, etc.

## Why is Human Rights Needed?

I could simply say that human rights are needed for protection. A more complete answer would be to state that human rights

- 1. Give us the freedom:
- a. to choose how we want to live;
- b. how we want to express ourselves;
- c. to choose what kind of government we want;
- 2. It guarantees us the means to satisfy our basic needs such as food, housing and education.
- 3. Lastly, by guaranteeing life, liberty, equality and security, human rights protect us against those who are more powerful.

Among the human rights, the "right to education" is one that is very well accepted internationally. This is one of the most important human rights because of its supporting nature. It means education is not only good in itself as it increases knowledge, it also gives people the ability to access and use other core rights.

It gives people the confidence to make informed decisions, either to protect themselves from having their rights disturbed or to hold those who abuse power responsible. It helps people to join more actively in their social and economic rights too, such as obtaining land rights and investments. So, these economic trends increase the importance of education because of the modernisation and easier access to information in the economy, particularly in Africa.

Who is Responsible for Upholding Human Rights? Under human rights treaties, governments have the primary responsibility for protecting and promoting human rights. However, governments are not solely responsible for ensuring human rights. The UDHR states:

"Every individual and every organ of society....shall strive by teaching and education to promote respect for these rights and freedoms...." This means that not only the government but also businesses, civil society and individuals are responsible for promoting and respecting human rights.

## **Human Rights in Omega**

The Omega Policy on Human Rights is based on the following principles:

- 1. Employees have the right to have their dignity respected and protected
- 2. Working conditions and practices will not infringe on the inherent dignity of employees
- 3. Physical, sexual, racial, religious, psychological, verbal or any other form of harassment, threat or abuse, whether manifested in behaviour, language or gesture is strongly condemned and will be prevented
- 4. Corporal punishment, mental or physical coercion or verbal abuse will not be tolerated encouraged or supported
- 5. Employees have the right to belong to cultural, religious or linguistic communities of their choice and may not be denied the right to enjoy their culture and practise their religion
- Employees have the right to make political choices and to exercise these rights outside of working hours

\_\_\_\_\_\_

- 7. Treating all of our stakeholders fairly and with dignity, irrespective of race, colour, gender, language, religion, political affiliation, national or social origin, or other status.
- 8. Recognising and upholding the rights of employees to freedom of association.
- 9. Recognising and upholding the rights of our employees and other stakeholders before the law, including the rights of indigenous people, residing at or near our operations.
- 10. Not engaging in child, forced and/or compulsory labour.
- 11. Recognising the right of our employees to fair treatment and to be remunerated according to agreements made with themselves or their representative unions.
- 12. Recognising the imperatives for change and transformation in some of the countries in which we operate.
- 13. Ensuring that our security personnel are aware of and have been trained to uphold our human rights policy.

On behalf of myself, the Group Executive, Senior Management and managers at all levels, I wish to confirm that in Omega we shall have a zero tolerance for not adhering to Human Rights.

# PROTECT CLN LINE

Arkhê Risk Solutions was contracted to protect the CLN line in Mozambique to ensure that a safe environment is created whereby the client may reach the projected export targets. Arkhê security officers secure the line between Moatize and the Malawi border in the section 2 area, 24 hours per day, 7 days per week and with very good results.

The Section 2 CLN line starts at the Moatize Coal terminal and terminates at the Malawi border about 62km from Moatize via Monga (line distance not road distance).

Arkhê Risk Solutions security officers have been deployed in this area from February 2016. They are recruited locally from the Cateme-, Tete City-, and Monga crossroad areas with the majority being from the Monga crossroad area.

Security officer numbers were gradually increased due to the intensification of criminal activities along the CLN corridor comprising: diesel theft, vandalizing railways and putting obstacles like rocks and pieces of lumber on the line in order to derail trains which in turn creates opportunity for fuel theft.

In order to make this operation more cost-effective the security plan has been designed to only use locally recruited and trained people [per zone] therefor eliminating the need for transport over long distances, facilitate shift changes and food distribution.

In this way Arkhê Risk Solutions are also actively contributing to the community, empowering and uplifting the local communities.

# THE CLN PORT Nacala Velha

The CLN Port at Nacala Velha is a multi-purpose Port from where all coking coal extracted from Vale in Moatize mine (Mozambique Tete Province) is exported for the Asiatic and European market.

The harbour is located in Nacala (Mozambique) and is a strategic asset for the country, since the Port is being used for all the coal extracted by the mother company VALE.



The Moatize project is expected to generate 8.5 million tonnes of metallurgical coal, which is used for the production of steel. It will also produce 2.5 million tonnes of thermal coal, which is used for electricity generation, every year.

Arkhê Risk Solutions presently has more than 500 security officers on the railway protection project, and more than 200 security officers in the harbour.

This operation involved the Arkhê Regional Manager, and four security officers plus one police officer. The Raid has taken two hours and culminated in the dismantling of 15 small camp sites where the striping cable is done.

# Assisting in the success

Remote monitoring compliments the physical security officer at many sites. The offsite monitoring is a great help by using carefully calculated and strategically placed cameras and this can offer strategic advantages to the effectiveness of the security function. Offsite monitoring clearly will not replace the onsite security officers. The purpose is to oversee the onsite security procedures, check and enforce the onsite procedures. The control room offers onsite support in the event of an incident and prepare management reports. The major role of the remote monitoring is to help the onsite team prepare an immediate response to what is happening on the ground. It creates the ability to filter nuisance alarms and inform security officers only when required. This offers peace of mind to the client.


There are adequate procedures and measures in place to minimize the possibility of human error and equipment failure.

Arkhê has been training the monitoring personnel to ensure that controller performance is according to predefined requirements. We will send transparent reports to the client and this should be in the contract. Arkhê has standard operating procedures for the operators which can include guard patrols verified visually, visits by supervisors, and reporting of incidents and actions taken.

The cameras allow for easy retrieval of images and the searching for images using specific intelligent software time is significantly reduced. The systems installed have a high picture image quality which allows for clear identification purposes.

Built in Intelligence line crossing and zone control that never sleeps will definitely contribute to the monitoring effectiveness. Video analytics are utilized to reduce false alarms and ensure the validity of the incident requiring attention. Video footage is recorded and preserved for at least 30 days for operators or clients to review.

These are Pumps erected in a strategic area and Total is the pioneer in the sale of Diesel of 50 ppm.



Montepuez Ruby Mine in Mozambique is the world's largest deposit of the highly coveted colored gemstones, ruby. The rubies found at Montapeuz Ruby mine are of a quality previously only thought possible in gemstones from Myanmar. They are comparable with the legendary rubies of Myanmar, which frequently command the highest price per carat of any colored gemstone.

Rubies were first discovered in Montepuez in 2009. As the story goes, a man working on the land, which was formerly a hunting concession, came across one of the red stones.

The sheer number of rubies makes the mining process relatively straightforward. This is openpit mining – in simple terms, mountains of rich red earth are scooped up in enormous diggers, transported to the wash plant and processed.



Rubies are much rarer than other precious stones. At present (2017), the world ruby supply consists of about three million cut and polished carats per year, compared to about five to eight million for emeralds and 50 million for diamonds.





## **KALUMBILA MINE**

Omega Risk Solution started the Kalumbila mine contract on 1st September 2012. In May 2017 the operational contract with Kalumbila Minerals was signed. Omega's involvement in the operation consists of managing the Kalumbila Mine Reception at the main gate, access control at the main gate and various other entry points to the mine. The mine covers a vast area and Omega has 74 deployment areas. In order to keep this workforce healthy, a kitchen is being manned by Omega personnel. It consists of seven chefs that prepare food twice a day. There is a brunch and supper prepared and then distributed to the officers. These trips are coordinated with inspectors visiting the sites. The Kalumbila Mine main check point is the heart of the mine and this is where all mine employees, contractors and visitors meet Omega officers for the first time. All drivers and passengers entering the mine area move through the main gate. All people are breathalyzed and ID's checked.
